Please supply the following information under the Local Government Official Information and Meetings Act:

- Submitters to the Akaroa Reclaimed Water Beneficial Reuse, Treatment and Disposal Options Consultation received an email from Bridget O'Brien on June 8, 2017 stating: *Two new flow meters are being installed to record new data. These flow meters will be calibrated to ensure accurate and validated data is recorded. We expect to have the new data available to our design team during the week beginning 19 June 2017. When the new data has been gathered, the design team will analyse it and assess any impact on the five options we consulted on.* Please supply an explanation of the methodology the Council intends to use to analyse the new data, when it expects to release information on the impact of this new data on the five consultation options to the public and the timeframe for any further formal further public input such as a hearing or revised consultation document.
